An anonymous donation has been pledged to SMS for the amount of \$500,000 specifically for site and facility acquisition exclusively!!!!

- b. Summary of conference call with Alison and next steps. Only about 15 minutes for the presentation and the remainder of the time will be a vigorous Q and A. The board will be particularly interested in how we addressed all concerns provided from their first staff review. There are two templates critical to our revision of the charter petition: the best and worst case budget scenarios and the site/facility selection template. These templates will be provided to the respective committees. It is okay to pack the house with supporters. We should choose carefully who we would like to "testify" on our behalf. These should be well chosen, succinct and providing information that would not be gleaned from the review of the charter. July 16th the reviewed petition due back to the Commission. We can add updated attachments a week out from the hearing, but the bulk of the documents should be provided by the July deadline. Budget, viable sites and community interest are understandably the three areas of highest concern by the Commission. We need to collect names of students "planning" to attend our school and the grade they would enter into SMS.

 - Site/facilities Committee: Phoebe reported on the conclusions reached from interviewing 5 prospective realtors. Don gave numerous examples of his experiences with Sage International and strongly suggested we consider working with a commercial realtor. Budget Committee: Ben, Don and Mike are investigating funding scenarios for financing a site/facility.
 - PR/Fundraising Committee: Becquel Smith is advising us on developing a marketing plan, branding, website, and our PPT to the Commission. Need to develop the student enrollment protocol and transporting parents to Boise.

- d. TMS update: An effort is being made to hire some part time staff to begin Waldorf mentoring and training for possible consideration for hiring at SMS school.
